PUPIL FREE DAY TERMS AND CONDITIONS

Attendance:

Parents/Caregivers must sign their child(ren) in/out using their PIN. Late collection after 6:00 pm incurs a fee.

Enrolments:

New enrolments for Pupil Free Day close on April 24th. Enrolment forms submitted late will be processed at the commencement of Term 2. We will unfortunately not be able to accept bookings for late enrolments.

Cancellations:

Once bookings have been processed, Pupil Free Day sessions fees cannot be removed with a cancellation. Fees remain claimable via CCS. Fee waiver possible with medical certificate or health notification before session.

Attire, Food, and Sun Protection:

Enclosed shoes are required; open-toe sandals are not permitted. Please ensure your child brings their school hat to the Pupil Free Day - No Hat No Play policy remains during recommended Sun Protection period according to BOM forecast. Please pack recess and lunch for your child - afternoon tea will still be provided. We are unable to heat food for students. **WE ARE STRICTLY A NUT-FREE SERVICE - NUT PRODUCTS NOT PERMITTED.**

Electronic Devices:

No hand-held gaming consoles or school laptops unless encouraged as part of the educational program. Mobile phones must strictly remain in the student's bag.

Medication:

National Regulation (90) - Under the Education and Care Services National Regulations, we are unable to have students attend the service if they have a diagnosed medical condition until the following documentation is provided or is currently in-date: 1) Medical Management Plan, 2) Medical Conditions Risk Minimisation Plan and Communication Plan, 3) Prescribed medication (provided in original packaging with a pharmacy label attached matching the details of the students Medical Management Plan). Families will be flagged if this is an issue at the time of booking.

Child Care Subsidy:

OSHC does not have any control over CCS, eligibilities, or CCS being removed from fees. CCS enquiries in these fields are best directed to Centrelink. It is the responsibility of our families to ensure their claim for CCS has been placed and approved. Families not receiving CCS are responsible for payment of the full vacation care fees.
